Re: Summary Wage Package + Agreement Revisions

The Summary Wage Package Breakdowns for the Residential Agreement and the Residential Letter of Understanding, which are effective February 3, 2025 through November 2, 2025, are enclosed.

In addition to a total package wage and benefit increase, the bargaining parties have agreed to a Memorandum of Understanding (M.O.U.) between the Northeastern Illinois Chapter of NECA and IBEW Local Unions 117, 150, 461 and 701. The M.O.U. includes provisions such as unlimited portability of all workers including apprentices and subclassifications, and all wages and fringe benefits to be paid back to the base local union. An executed M.O.U. will be provided shortly upon final signatures.

Additionally, the bargaining parties will continue to discuss attempts to expand the residential market with IBEW Sixth District. Efforts to expand the residential market beyond the above stated M.O.U. may include additional local unions in Northern Illinois and more flexible working provisions. Details on the progress of these discussions will be provided once finalized.
