Please note that the wage and benefit package for VDV Technicians performing fire alarm work* is set at 85% of the Inside Journeyman wage and is subject to change on the anniversary date of the Inside Agreement.

* Fire Alarm work that falls under the Davis-Bacon Act, Illinois Prevailing Wage Laws, Project Labor Agreements and/or work funded by Union trust funds shall be paid at one hundred percent (100%) of the Inside Journeyman Wireman wage and fringe benefit package.
